2. Decides to recommend that the General Conference admit representatives of this organization to its fourth. extraordinary session as observers.

ITEM 3 - CONSIDERATION OF COMMUNICATIONS RECEIVED FROM MEMBER STATES INVOKING THE PROVISIONS OF ARTICLE IV.C, PARAGRAPH 8(c), OF THE CONSTITUTION CONCERNING THE VOTING RIGHTS OF MEMBER STATES IN ARREARS WITH THEIR CONTRIBUTIONS, AND RECOMMENDATIONS OF THE EXECUTIVE BOARD THEREON (3 X/EX/3)

The Executive Board,

1. Having considered document 3 X/EX/3 submitted by the Director-General on this matter,
2. Having considered the communication received from the Dominican Republic,
3. Noting that, according to information provided by this Member State, its non-payment of arrears of contributions is due to circumstances beyond its control,
4. Recommends to the General Conference that, by virtue of the powers vested in it by Article IV.C 8(c) of the Constitution, it authorize this Member State to participate in the voting at its fourth extraordinary session.
