ELECTION OF MEMBERS OF THE EXECUTIVE BOARD

1. Pursuant to Article V.A, paragraph 4(a), of the Constitution, the General Conference, at its 31st session, has to elect 29 Member States to fill the vacancies occurring at the end of the session in the membership of the Executive Board.
2. At its 17th session, the General Conference decided, by resolution 12.1 to adopt as its normal practice, the system of electoral groups established at its 15th session.
3. Annex I contains the current composition of the Executive Board by electoral group as established by the General Conference at its 15th session and modified at its 17th, 18th, 19th, 20th, 21st, 22nd, 23rd, 28th, 29th and 30th sessions.
4. It is to be noted that since the 30th session of the General Conference the Federal Republic of Yugoslavia has become a member of UNESCO.
5. In the light of the above, the Nominations Committee of the 31st session of the General Conference may wish to recommend to the General Conference that it approve the inclusion of the Federal Republic of Yugoslavia in electoral Group II.
6. Pursuant to Article 1 of the special provisions governing the procedure for the election of Member States to the Executive Board, the Director-General sent out circular letter CL/3581 dated 24 April 2001 requesting Member States to inform him if they intended to stand for election to the Executive Board at the 31st session of the General Conference. The provisional list of Member States whose candidacies had been communicated to the Director-General by 10 October 2001 is set out in Annex II.
7. In accordance with Article 4 of the above-mentioned procedure, subsequent candidacies will be admissible only if they reach the Secretariat of the General Conference at least 48 hours before the opening of the meeting at which the election is to take place. According to the provisional timetable of work, this meeting is scheduled for Friday, 26 October 2001.
8. Annex III contains information on the mandate of Members of the Executive Board and on candidacies at the 31st session of the General Conference.
