**DRAFT PROVISIONAL TIMETABLE OF WORK OF THE

1. The Chairperson of the CI Commission submits for the approval of the Commission the draft provisional timetable of work, which has been drawn up in conformity with the recommendations formulated by the Executive Board and approved by the General Conference concerning the context and the overall schedule for the work of this Commission.

2. The CI Commission is responsible for examining the following items during three debates:

(Debate 2)                      **Summit on the Information Society** (35 C/46)

The Director-General submits to the General Conference a follow-up report on all decisions taken by the World Summit on the Information Society so that the General Conference may discuss the results obtained since the second phase of the Summit (Tunis, 2005) and UNESCO's role in the implementation thereof.

**Item 5.16**                      **Multicultural Library Manifesto of the International Federation of**  
(Debate 3)                      **Library Associations and Institutions (IFLA)** (35 C/51)

3. The draft resolutions proposing amendments of, and the recommendations by the Executive Board on, the Draft Programme and Budget for 2010-2011 (35 C/5), Major Programme V will be examined at the end of Debate 1. The draft resolution contained in paragraph 39 of document

35 C/46 will be considered at the end of Debate 2 and the draft resolution contained in paragraph 7 of document 35 C/51 will be considered at the end of Debate 3.

4. After the conclusion of each debate, the representative of the Director-General, the Assistant Director-General for Communication and Information, will reply to questions that delegates may have.

5. At its sixth meeting (20 October 2009, 10 a.m. to 1 p.m.), the CI Commission will consider its report and make its recommendations concerning Major Programme V as a whole, including the budget.
