PROVISIONAL TIMETABLE OF WORK OF THE SHS COMMISSION

MAJOR PROGRAMME III

From 16 to 19 October, and 21 October

1. The Chairperson submits for the approval of the Commission the provisional timetable that has been drawn up taking into account the organization of the work of the session as approved by the General Conference (35 C/2 Rev. and Add.) and in accordance with the agenda of the General Conference (35 C/1 Prov. Rev. and Add.).
2. The debate on the Draft Programme and Budget for 2010-2011 – Part II.A: Major Programme III – Social and Human Sciences (item 4.2) will take place during sessions 3, 5 and 6 of the Commission. The Chairperson draws attention to the fact that this debate will consist of three separate discussions, on Biennial Sectoral Priority 2, Biennial Sectoral Priority 1 (Main Line of Action 1) and Biennial Sectoral Priority 1 (Main Lines of Action 2 and 3), respectively.
3. The Chairperson reminds the Commission of the need to keep to the timetable and to avoid delays. Time for interventions by delegations will be limited to two minutes for each sub-discussion on item 4.2 and to three minutes for all other items. If the work of the Commission progresses faster than expected, the Chairperson reserves the right to move on to the examination of an item initially scheduled for the following session. If the work of the Commission progresses more slowly than expected, the Chairperson reserves the right to reduce the time for interventions by the Delegations.
4. The Chairperson draws attention to the fact that item 5.12 will be examined during a joint session of the SC and SHS Commissions which will be held on Friday morning, 16 October at 10.30 a.m.
5. The Commission will adopt its report on 21 October at 3 p.m. The recommendations of the SHS Commission will thereafter be submitted for approval in the plenary meeting of the General Conference.
