The Executive Board,

1. Having examined the report on donations and special contributions received since the beginning of the biennium and appropriated to the regular budget and transfers made between appropriation lines including those from Part IV and the reserve for reclassification/merit-based promotions to the Sectors/Bureaux pursuant to 35 C/Resolution 106, paragraphs 2(b), (d) and (e),

2. Notes that the Director-General has, as a consequence of donations and special contributions received since the beginning of the biennium, increased the appropriations to the regular budget by a total of **\$2,267,577** as follows:

Recalling paragraph 2(d) of the Appropriation Resolution for 2010-2011 by virtue of which the Director-General is authorized, with the prior approval of the Executive Board, to make transfers from Part IV of the budget (Anticipated Cost Increases) to the relevant appropriation lines in Parts I-III in order to cover increases in staff costs and in the cost of goods and services,
5. Further recalling paragraph 2(e) of the Appropriation Resolution for 2010-2011 by virtue of which the Director-General is requested to obtain prior approval of the Executive Board in instances where transfers between appropriation lines entail an amount greater than 1% of the initial appropriation,
6. Noting that the Director-General has identified the funding source for the construction of the forward security post at Fontenoy, further to its previous discussions and, in particular, in accordance with 185 EX/Decision 30, and proposed a financing plan for the urgent requirement relating to the telecommunication facilities, in line with the recommendation of the Headquarters Committee,
7. Approves the transfer of **\$4,452,400** from Part IV to Parts I-III of the budget to cover increases in staff costs and in the cost of goods and services, including, on an exceptional basis, the financing of the urgent requirements for security (which will be transferred to a special account) and the communication system, as set out in document 187 EX/4 Part II;
8. Further approves the transfer of **\$2,000,000** from the reserve for reclassifications/merit-based promotions to Parts I-III of the budget to cover costs resulting from the reclassification and merit-based promotion exercises, as well as, on an exceptional

basis, for the financing of the new communication system, as set out in document 187 EX/4 Part II;

9. Invites the Director-General to examine other possible sources of funding to complete the setting up of the new communication system, and to make a recommendation to it at its 189th session;

5 **Report by the Director-General on the follow-up to decisions and resolutions adopted by the Executive Board and the General Conference at their previous sessions** (187 EX/5; 187 EX/54)

Implementation of 35 C/Resolution 49 and 186 EX/Decision 5 relating to the Ascent to the Mughrabi Gate in the Old City of Jerusalem¹

The Executive Board,

1. Having examined document 187 EX/5,
2. Recalling previous UNESCO decisions, including 176 EX/Special Plenary Meeting/Decision, and the decision of the World Heritage Committee at its 34th session (Brasilia, 2010) relating to the Ascent to the Mughrabi Gate in the Old City of Jerusalem,
3. Also recalling the relevant provisions on the protection of cultural heritage including in the four Geneva Conventions (1949), the relevant provisions of the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict of 1954, the Convention for the Protection of the World Cultural and Natural Heritage of 1972, the inscription of the Old City of Jerusalem and its Walls at the request of Jordan on the World Heritage List (1981) and on the List of World Heritage in Danger (1982), and the recommendations, resolutions and decisions of UNESCO,
4. Reaffirming the purpose and spirit of the professional encounter at the technical level of 13 January 2008, as well as the follow-up meeting of 24 February 2008,
5. Noting the Sixth Reinforced, Seventh, Eighth and Ninth Monitoring Reports and its addendum prepared by the World Heritage Centre,
6. Recognizes the concerns raised in this regard about the decision by the Jerusalem District Planning and Construction Commission on the town planning scheme for the Mughrabi Ascent, and the subsequent decision by Israel's National Council for Planning and Construction to adopt "an alternative plan for the Mughrabi Ascent", approved on 31 October 2010 by the above-mentioned Commission;
7. Requests that, despite the decisions mentioned in paragraph 6, the process for the design of the Mughrabi Ascent be inclusive of all parties concerned, in accordance with the obligations and duties of such parties, as stipulated in the content of previous World Heritage Committee decisions;

8. Reaffirms in this regard, that no measures, unilateral or otherwise, should be taken which may affect the authenticity and integrity of the site, in accordance with the Convention for the Protection of the World Cultural and Natural Heritage of 1972 and the relevant provisions on the protection of cultural heritage of the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict of 1954;
9. Notes the request made by the World Heritage Committee in previous decisions, and asks, in this regard, that the Israeli authorities continue full cooperation with all concerned parties, in particular with Jordanian and Waqf experts;
10. Acknowledges receipt of the Jordanian design for the restoration and preservation of the Mughrabi Ascent, submitted to the World Heritage Centre on 27 May 2011, and thanks Jordan for its cooperation in accordance with the relevant provisions of UNESCO conventions for the protection of cultural heritage;
11. Affirms, in this regard, that the UNESCO-initiated process for the follow-up of the design of the Mughrabi Ascent, which is aimed at proactively facilitating an accepted and monitored solution concerning the Mughrabi Ascent among all parties concerned should be coordinated with all such parties, in accordance with the spirit and content of previous World Heritage Committee decisions;
12. Acknowledges in this regard, the concerns raised regarding Israel's submission and the content of its alternative plan for the Mughrabi Ascent, referred to in paragraph 6, and requests that the World Heritage Centre be proactive and follow closely, in the context of the Reinforced Monitoring Mechanism, the developments associated with this process;
13. Notes with satisfaction the access provided by Israel to the Mughrabi Ascent for Jordanian and Waqf experts on 23 May, 8 August and 28 November 2010, and reiterates its request that Israel continues the cooperation commenced with all parties concerned, in particular with Jordanian and Waqf experts to enable agreement on, among all parties concerned, and implementation of a final design for the restoration and preservation of the Mughrabi Ascent;
14. Also notes in this regard, reports of preliminary discussions between Jordan and Israel concerning the Mughrabi Ascent, which stipulate, *inter alia*, that no measures, unilateral or otherwise, shall be taken on the site, in accordance with paragraph 8 above, and the necessity of an accepted design and implementation thereof among all parties concerned, and welcomes the recognition by the parties concerned of the need for coordination on this issue;
15. Expresses its thanks to the Director-General for the action she is taking to facilitate the dialogue and professional exchanges among all the parties concerned;
16. Reiterates the call by the Director-General to organize a follow-up meeting of experts as soon as possible, once the parties concerned have reached an agreement;
17. Invites the Director-General to submit to it a progress report on this matter at its 189th session.

**Implementation of the UNESCO strategy for the second half
of the United Nations Decade
of Education for Sustainable Development (2005-2014)**

The Executive Board,

1. Recalling 177 EX/Decision 9, 184 EX/Decision 11 and 186 EX/Decision 6 (III),
2. Having examined document 187 EX/6 Part I,
3. Welcomes the Director-General's efforts to mobilize all UNESCO programme sectors and networks to enhance their contributions to education for sustainable development (ESD) and the United Nations Decade of Education for Sustainable Development (2005-2014), to ensure an intersectoral implementation of the UNESCO strategy for the second half of the Decade at the global and regional levels, and to support Member States in further reinforcing the integration of ESD into their national programmes and plans;
4. Invites the Director-General to continue her efforts in the implementation of ESD and the Decade during the next biennium in order to assist Member States and regions, taking into account development priorities identified by them in the educational, political, economic and social spheres;
5. Encourages all Member States to strengthen their efforts to implement UNESCO's strategy in the second half of the Decade at the international, regional, national and local levels;
6. Also invites the Director-General to mobilize Member States and other stakeholders to contribute to the preparations of the end-of-decade conference in 2014 to be organized jointly by UNESCO and the Government of Japan to review the tangible results of the Decade in order to determine the future direction of ESD.

II

Cultural and educational institutions in Iraq

The Executive Board,

1. Recalling 185 EX/Decision 35,
2. Having examined document 187 EX/6 Part II,
3. Acknowledges, with appreciation, the results achieved in the implementation of educational, cultural, scientific and media activities and the continued mobilization of substantial extrabudgetary resources to this effect;
4. Encourages the Director-General to continue to give full support to the Iraqi Government in its implementation of educational, cultural, scientific and media programmes, in particular through capacity-building activities and by addressing the most urgent humanitarian needs of the populations most affected by the crisis, including displaced Iraqis;

5. Invites the Director-General to continue monitoring the implementation of the recommendations of the International Coordination Committee for the Safeguarding of the Cultural Heritage of Iraq (ICC);
6. Expresses its gratitude to all donors for their substantial contribution to UNESCO's action in favour of the Iraqi people, and appeals to them to continue to assist UNESCO in its efforts to foster reconstruction and dialogue in Iraq;
7. Calls upon donors to sustain their funding through the funds-in-trust modality established within the United Nations Development Assistance Framework (UNDAF);
8. Further invites the Director-General to submit a progress report to it at its 190th session.

III

Progress achieved in the implementation of the Strategy for Technical and Vocational Education and Training (TVET)

The Executive Board,

1. Having examined document 187 EX/6 Part III,
2. Encourages the Director-General to strengthen the Organization's efforts to advance the implementation of the Strategy for Technical and Vocational Education and Training (TVET) at all levels, including through the use of information and communication technologies (ICTs);
3. Invites the Director-General to report to it at its 189th session on the preparation of the Third International Congress on Technical and Vocational Education and Training, and to submit to it a detailed plan of implementation for the Strategy for Technical and Vocational Education and Training;
4. Requests the Director-General to present to it at its 190th session a preliminary report on the mid-term review of the implementation of the Strategy for Technical and Vocational Education and Training, and to prepare a TVET best-practices document for wider dissemination.

UNESCO's contribution to the Mauritius Strategy for the Further Implementation of the Barbados Programme of Action for the Sustainable Development of Small Island Developing States (SIDS)

The Executive Board,

1. Recalling 185 EX/Decision 41,
2. Having examined document 187 EX/6 Part IV,
3. Takes note of the Director-General's efforts to ensure that UNESCO's contribution to the Mauritius Strategy for the Further Implementation of the Barbados Programme of Action for the Sustainable Development of Small Island Developing States, coordinated by the dedicated intersectoral platform, continues to be implemented with the active involvement of all major programmes at Headquarters and in the field;
4. Encourages the Director-General to seek extrabudgetary funds to supplement the regular budget funds intended for the implementation of the intersectoral platform.

**Promotion of South-South cooperation:
Strategic partnership for the operationalization of the
Consortium on Science, Technology and Innovation for the South (COSTIS)]**

Sub-item 6 Part V proposed in document 187 EX/1 Prov. Draft was subsumed under item 5 “Report by the Director-General on the follow-up to decisions and resolutions adopted by the Executive Board and the General Conference at their previous sessions”, and addressed in document 187 EX/5.

Cooperation between UNESCO and the Global Geoparks Network (GGN)

The Executive Board,

1. Having examined document 187 EX/6 Part VI,
2. Recommends that the General Conference adopt the following draft resolution at its 36th session:

“The General Conference,

Welcoming the positive impact of geoparks on education, sustainable development and the cultural identity of a region, and the considerable progress achieved by the Global Geoparks Network (GGN),

Highlighting the important contribution of geology and geoparks to the mitigation of climate change and geological hazards,

Recalling the need to assist Member States in establishing geoparks in their countries, especially in developing countries, and in ensuring strong capacity-building in Latin America and the Caribbean and Africa,

Bearing in mind that geoparks activities have been performed successfully for 11 years and have developed into a global network of 78 geoparks in 26 countries with the full support of the World Conservation Union (IUCN) and the International Union of Geological Sciences (IUGS),

Further recalling that the geoparks initiative contributes to enhancing UNESCO’s visibility, while at the same time having low operating and secretariat costs and the potential of attracting extrabudgetary funds to the Organization,

Requests the Director-General:

- (a) to continue to improve cooperation between UNESCO and the Global Geoparks Network (GGN) and to strengthen the global development of geoparks while improving the quality standards they have already developed,
- (b) to ensure a reference to geoparks in document 36 C/5,
- (c) to explore, in consultation with Member States, the possibilities of formalizing the current geoparks initiative, *inter alia*, by examining the possibility of transforming it into an international UNESCO geoparks programme or initiative, including the financial and administrative implications thereof,

- (d) to that end to consult in a cost-effective manner with Member States, the Global Geoparks Network, experts and all parties concerned, including relevant UNESCO sectors, to carry out the following actions:
- (i) examine the feasibility of establishing a possible UNESCO geoparks programme or initiative, building on the existing success and experience of the Global Geoparks Network and geoparks;
 - (ii) discuss and formalize the baselines of such a programme or initiative, its working methods, questions of competency, representativeness, and involvement of relevant official partners and qualified persons;
 - (iii) explore fundraising opportunities and modalities which would allow UNESCO to strengthen international networking and assist emerging geopark projects in developing countries, with a special focus on Latin America and the Caribbean and Africa;
 - (iv) assess options for arrangements for a formal partnership with the Global Geoparks Network;
- (e) to report to the Executive Board on this matter at its 190th session.”

VII

Evaluations completed in the 2010-2011 biennium

The Executive Board,

1. Recalling 186 EX/Decision 6 (VI),
2. Having examined documents 187 EX/6 Part VII and 36 C/INF.16,
3. Welcomes the evaluation completed, and invites the Director-General to implement those recommendations that do not require a decision by the Executive Board and/or the General Conference;
4. Takes note of the ongoing review of the cooperation of the UNESCO Secretariat with the National Commissions for UNESCO, and also invites the Director-General to report thereon to the General Conference at its 36th session.

VIII

Implementation of the Participation Programme and emergency assistance

The Executive Board,

1. Having examined document 187 EX/6 Part VIII,
2. Takes note of the detailed analysis of the implementation of the Participation Programme and emergency assistance, and welcomes the results achieved;
3. Recognizes, however, that ongoing and sustained efforts are still required to further strengthen the Participation Programme by optimizing it with a view to enhancing its effectiveness and relevance in addressing the priority needs of Member States, in developing countries, in particular Africa, the least developed countries, small island developing States (SIDS), as well as those with economies in transition, middle-income

countries and other priority country groups, in accordance with the principles set out in the draft resolution on the Participation Programme in document 36 C/5 Draft Addendum Vol. 1;

4. Also recalling the Executive Board’s invitation to the Director-General “to develop, in close cooperation with Member States, a draft comprehensive and outward-looking UNESCO policy framework for strategic partnerships, to be submitted to it at its 187th session for transmission to the General Conference at its 36th session” (186 EX/Decision 17 (I), para. 56), and its suggestion “to include in the comprehensive policy framework distinct strategies for each category of partners, within the whole range of UNESCO’s programmes” (186 EX/Decision 17 (I), para. 58),
5. Emphasizing the role of National Commissions in liaising with partners at the national level, including with the private sector,
6. Welcomes the Annex of document 187 EX/6 Part XII, which provides a listing of the various components of a future comprehensive partnership strategy, and document 187 EX/17 Part IV, which sets out in draft form an umbrella statement for partnerships by UNESCO;
7. Requests the Director-General to refine further the umbrella statement on partnerships, in light of the discussions at its 187th session, and to further expand and complement it through separate strategies for engagement with the private sector, media companies, civil society and NGOs, parliamentarians, Associated Schools, UNESCO Clubs, UNESCO Chairs and other partners;
8. Also requests the Director-General to further develop the draft strategy on private partnerships (Annex to document 187 EX/6 Part XII) under the umbrella statement and within the draft policy framework in order to avoid overlap;

Takes note of the postponement of the examination of the report on the implementation of the 1974 Recommendation on the Status of Scientific Researchers as well as of the accordingly revised timetable of work of the Committee on Conventions and Recommendations for 2009-2013 on the monitoring and implementation of UNESCO's standard-setting instruments;
5. Invites, in consequence, the Director-General to submit to it at its 189th session the consolidated report on the application of the 1974 Recommendation, so that it might be transmitted to the General Conference at its 37th session, together with the comments of the Executive Board;
6. Requests the Director-General to ensure the implementation of the new legal framework by the programme sectors and the UNESCO Institute of Statistics (UIS), which have responsibility for the conventions and recommendations monitored by the Committee on Conventions and Recommendations;

Further recalling 177 EX/Decision 35, 184 EX/Decision 20 and 186 EX/Decision 19 (III),

1. *Takes note* of the report on the implementation of the 1993 Recommendation on the Recognition of Studies and Qualifications in Higher Education;
2. *Recognizes and welcomes* the progress made in the implementation of certain items of the Recommendation, in particular the adoption of comprehensive policies and legislation on recognition of studies and qualifications;
3. *Invites* all Member States to strengthen their efforts to ensure the full and comprehensive implementation of the items of the 1993 Recommendation, to recognize knowledge as universal and a part of the common heritage of humankind, and to promote greater access to knowledge and learning for each individual;
4. *Invites* the Director-General to:
 - (a) promote the development of institutional arrangements for the implementation of the 1993 Recommendation through the six conventions on the recognition of studies and qualification in higher education;
 - (b) provide effective technical support to Member States in need to facilitate such recognition across all regions; and
 - (c) continue monitoring the 1993 Recommendation as a matter of priority, particularly in the context of the revisions of regional and interregional conventions on the recognition of studies and qualifications in higher education.”

III

Application of the 1970 Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property

The Executive Board,

1. Bearing in mind Member States' obligations under Article VIII of the Constitution of UNESCO and Article 17 of the Rules of Procedure concerning recommendations to Member States and international conventions covered by the terms of Article IV, paragraph 4, of the Constitution,
2. Recalling 177 EX/Decision 35 (I and II) and 184 EX/Decision 25,
3. Having examined document 187 EX/20 Part III and the report of the Committee on Conventions and Recommendations (CR) thereon contained in document 187 EX/50,
4. Noting that the number of reports submitted by States Parties to the 1970 Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property remains very inadequate in view of the obligation of each State Party to report under Article 16 of the Convention,
5. Noting with satisfaction that some Member States not yet Parties to the 1970 Convention have provided information on the action taken in respect of the Convention, and in particular regarding their intention to ratify or accept it,
6. Stressing the importance of transmitting to UNESCO precise information on the measures taken by States to protect cultural property on their territory, particularly in regard to the successes, failures and obstacles encountered in implementing the Convention, and information on any requests for assistance that they may have made in that respect,
7. Considering that action to combat trafficking in cultural property needs to be strengthened at both the national and international levels,
8. Invites the States that are not yet Parties to the 1970 Convention and to the 1995 UNIDROIT Convention, which complements it, to ratify or accept these conventions;
9. Reminds States Parties of their obligations under the 1970 Convention in respect of effective implementation, and in particular their reporting obligations under Article 16 thereof;
10. Emphasizes that the content of such reports should be as detailed as possible to enable an accurate understanding and evaluation of the implementation of the 1970 Convention,
11. Encourages States Parties to the 1970 Convention to assess the national measures taken to implement the Convention so that areas of weakness may be identified and appropriate adjustments or improvements made;
12. Invites Member States and the Director-General to pursue activities aimed at strengthening regional and international cooperation, in particular by encouraging the introduction of an international mechanism to facilitate the restitution of stolen or illicitly exported cultural property;
13. Also invites the Director-General to transmit to the General Conference at its 36th session the summary of the reports received from Member States on the measures

taken for the implementation of the 1970 Convention, together with the Executive Board's comments and any comments that the Director-General may wish to make.

Application of the 1989 Convention on Technical and Vocation Education and the 2001 Revised Recommendation concerning Technical and Vocation Education

The Executive Board,

1. Recalling 34 C/Resolution 87, 177 EX/Decision 35 (I and II) and 184 EX/Decision 20,

Requests the Director-General to include in the preparation for the Third International Congress on TVET in May 2012 a discussion on the content, relevance and scope of the 1989 Convention on Technical and Vocational Education and of the 2001 Revised Recommendation concerning Technical and Vocational Education, in order to allow the Organization to review these standard-setting instruments;
5. Decides to resume consideration of this item at its 190th session, and takes note of the revised 2009-2013 timetable of work of the Committee on Conventions and Recommendations on the monitoring of the implementation of UNESCO's standard-setting instruments.

Application of the 1976 Recommendation on the Development of Adult Education

The Executive Board,

1. Having examined document 187 EX/20 Part VI and the report of the Committee of Conventions and Recommendations (CR) thereon contained in document 187 EX/50,
2. Invites the Director-General to transmit document 187 EX/20 Part VI to the General Conference at its 36th session, along with the comments of the Executive Board thereon;
3. Recommends that the General Conference adopt the following draft resolution,

“The General Conference,

Recalling that at its 19th session (Nairobi, 1976), it adopted the Recommendation on the Development of Adult Education,

Also recalling that at its 27th session (Paris, 1993), it invited the Director-General to ensure the functioning of the permanent reporting system for the monitoring of the 1976 Recommendation,

Further recalling 34 C/Resolution 87, 177 EX/Decision 35, and 184 EX/Decision 20,

1. *Takes note* of the mechanisms of the International Conference on Adult Education (CONFINTEA) process, especially the *Global Report on Adult Learning and Education* and the Belém Framework for Action, which facilitate the implementation and monitoring of the Nairobi Recommendation;
2. *Recognizes and welcomes* the progress made in the implementation of certain provisions of the Nairobi Recommendation, in particular the adoption of comprehensive adult education policies and legislation, *but regrets* that many factors, especially the non-availability of funds and insufficient provision and quality of learning opportunities, still impede the development of adult education within a lifelong learning framework;
3. *Invites* all Member States to strengthen their efforts to ensure the full and comprehensive implementation of the provisions of the Nairobi Recommendation, and to recognise the key role of adult literacy and adult education for the achievement of the Millennium Development Goals (MDGs), education for all (EFA) and the United Nations agenda for sustainable human, social, economic, cultural and environmental development;
4. *Encourages* all Member States to mobilize all stakeholders to undertake a national monitoring process for the preparation of triennial progress reports on the implementation of the Belém Framework for Action to provide necessary information to monitor the implementation of the Nairobi Recommendation;
5. *Invites* the Director-General to:
 - (a) approach the other United Nations specialized agencies to initiate an interagency and intersectoral approach and include adult literacy and adult education as key components of United Nations interventions, such as the Delivering as One initiative;
 - (b) provide technical support to Member States, where needed, in their implementation of the Nairobi Recommendation and the Belém Framework for Action;
 - (c) take into account and disseminate best practices implemented in the Member States in the area of literacy and adult education;
 - (d) take necessary steps to ensure that the *Global Report on Adult Learning and Education* is prepared once every three years on the basis of triennial national progress reports as the appropriate and effective means for monitoring the implementation of the Nairobi Recommendation;
 - (e) consider the review and updating of the Nairobi Recommendation in reflection of contemporary educational, cultural, political, social and economic challenges as set out in the Belém Framework for Action, and submit to it at its 189th session (spring 2012) a plan of action for its review.

 - (b) the discount shall be based on effective interests earned during the relevant year, net of investment fees and bank charges;
 - (c) the distribution shall be made after the closing of accounts of the relevant year; the interest earnings shall be deducted from the assessed contributions owed the following year;
 - (d) the yearly discount rate shall be based on the average interest rates in US dollars (London Interbank Bid Rate (LIBID) USD 1 month) and in euros (LIBID EUR 1 month) from January to June, and weighted with the assessment split;

 - (d) invitations to send observers to the above-mentioned meeting shall be extended to organizations of the United Nations system with which UNESCO has not concluded mutual representation agreements, to other intergovernmental organizations, and to international non-governmental organizations;
5. Authorizes the Director-General to extend any other invitations that she may deem conducive to the work of the Meeting of States Parties to the 1970 Convention, subject to the approval of the Executive Board at its 189th session.

Considering the various action plans and recommendations resulting from the celebration of the International Year of Languages throughout the world, including the Lena Resolution adopted by the International Conference on Linguistic and Cultural Diversity in Cyberspace (Yakutsk, Russian Federation, 2-4 July 2008), the Bamako Commitment on Universal Multilingualism adopted by the Bamako International Forum on Multilingualism (Bamako, Mali, 19-21 January 2009) and its Action Plan, and the Yakutsk Call for Action: a roadmap towards the World Summit on Multilingualism (2017) adopted by the Second International Conference on Linguistic and Cultural Diversity in Cyberspace (Yakutsk, Russian Federation, 12-14 July 2011), together with a framework for cooperation and partnership among languages (187 EX/44 and Add.),
5. In view of the importance of universal multilingualism and its contribution to the implementation of the Global Agenda for Dialogue among Civilizations and its various components, to the building of peace, intercultural dialogue, democracy and sustainable development, and to the achievement of the Millennium Development Goals (MDGs) and, in particular, education for all (EFA),
6. Decides to recommend that at its 36th session the General Conference consider the possibility of implementing, through the use of extrabudgetary funds, follow-up activities on the outcomes of the International Year of Languages.

6. Welcomes the initiative of the Republic of Korea to support and host the first World Humanities Forum, which will be held in Busan, Republic of Korea, from 24 to 26 November 2011;
7. Encourages Member States, international organizations, civil societies and the private and public sectors to enhance efforts to promote UNESCO human sciences, and to participate in the World Humanities Forum for the promotion of intellectual dialogue and exchange;
8. Requests the Director-General to consider the World Humanities Forum as an important milestone for UNESCO and its promotion of the human sciences, foster the human sciences in UNESCO's sectoral initiatives and programmes, and reaffirm UNESCO's commitment to the role of the human sciences in tackling pressing global challenges.

6. Taking into consideration the information provided by the Director-General at its 187th session,
7. Decides to establish a working group presided over by the Chair of the Executive Board, and comprised of three Members from each regional group;

Requests the working group, in the light of 185 EX/Decision 47, and taking account of the information provided by the Director-General at the 187th session, to undertake further consultations, in close collaboration with the Director-General, with a view to reaching a conclusion on this subject by the 189th session of the Executive Board.
